Solar options for your business

Onsite Installation

Your business can access solar energy by having solar panels installed on the roof of your building or property. If you do not have a roof that is ideal for solar, you should consider a ground-mounted system or community solar.

Remote or Community Solar

Community solar is great for businesses where rooftop or ground-mounted solar panels are not ideal. Community solar projects are a collective array of solar panels installed in a sunny, offsite location. By becoming a community solar member, you support the development of clean energy in your community while earning credits that reduce the cost of your electricity bills.

Solar Plus Energy Storage

If you are using renewables, energy storage systems allow you to store electricity and use it when you need it the most. When storage is paired with solar, your building's power supply is more resilient, and you experience increased savings and a better return on investment. Energy storage complements all types of solar, such as on-site panels, off-site arrays, and community solar projects. Storage can also integrate with other energy efficiency and demand-response upgrades within a building to increase energy savings without sacrificing occupant comfort and often provide backup power in case of emergency.

NYSERDA incentives

NYSERDA makes going solar easier and more affordable for New York's business owners.

By working with a NYSERDA-approved participating contractor, you may be eligible for incentives that lower the costs of going solar. NYSERDA is also providing incentives for businesses who pair solar with energy storage.
