TITLE: SCHOHARIE COUNTY INDUSTRIAL SOLAR PROJECT PAYMENT IN-LIEU OF TAXES [PILOT] RESOLUTION

WHEREAS, Schoharie County recognizes the importance of Renewable and Solar Energy while also considering the interests of the taxpayers and residents of Schoharie County and;

WHEREAS, Solar Energy Development Companies are active in Schoharie County; and

WHEREAS, Industrial Solar Developers may apply for Payment In-Lieu of Taxes [PILOT] Agreements through the Schoharie County Industrial Development Agency [SCIDA] instead of fully assessed taxation by the applicable taxing jurisdictions including the host-community Towns, Villages, County and School Districts and;

WHEREAS, the Schoharie County Board of Supervisors hereby sets a minimum Payment In-Lieu of Taxes [PILOT] rate of taxation to be not less than the amount of Twenty Thousand [\$20,000] Dollars per each rated megawatt [mW] of project nameplate capacity and;

WHEREAS, the Schoharie County Board of Supervisors recommends the Schoharie County Industrial Development Agency [SCIDA] not approve any Industrial Solar Development Project PILOT application for less than the amount of Twenty Thousand [\$20,000.00] Dollars per each rated megawatt [mW] of project nameplate capacity and in accordance with all other standard and traditional SCIDA terms, conditions and regulations, now, thereby be it hereby

RESOLVED, the Schoharie County Board of Supervisors agrees to and is in support of this Resolution in safeguarding the interests of the taxpayers and residents of Schoharie County.
