# **Charge Ready NY 2.0**

Rebate for Level 2 Charging Stations





## **Understanding Incentives for Charging Stations**

Following the success of the Charge Ready NY Program, NYSERDA launched the Charge Ready NY 2.0 Program. Charge Ready NY 2.0 is designed to accelerate the deployment of EV charging equipment in New York State by incentivizing the purchase and installation of Level 2 charging stations across public sites, workplaces, and multi-unit dwellings, with additional incentives given to Disadvantaged Communities (DAC).

### Which Charging Stations Qualify for the Rebate?

The Charge Ready NY 2.0 rebate applies to Level 2 charging stations. These charging stations typically have one or two plugs—or charging ports—per station and provide up to 25 miles of electric range to cars for each hour they are charging. There is a list of eligible Level 2 charging stations on the Charge Ready NY 2.0 website.

To qualify for the Charge Ready NY 2.0 rebate, charging stations installed at public locations, workplaces, and MUDs must be networked, meaning they must have the ability to connect to a network that can collect data and process payments.

### **How Does the Rebate Work?**

Charging station purchasers across New York State can participate in Charge Ready NY 2.0—any public or private entity, such as municipalities, for-profit companies, and non-profit organizations, are eligible for the rebate.

First, select a rebate-eligible charging station that has been approved through the Charge Ready NY 2.0 RFQL 5312 <u>equipment and network qualification process</u>. Then go to <u>nyserda.ny.gov/charge-ready-ny</u> to sign up and go through the application process. You can apply for a rebate before you install your charging station and have up to 180 days to complete installation or apply within 90 days of installing one. Once you have submitted all required documentation and it has been approved, you will receive your rebate from NYSERDA.

### **Incentive Amounts**

#### **Publicly owned facilities:**

- \$4,000 per single-port station
- \$8,000 per two-port station
- Minimum of four charging ports per site

### Workplaces and multi-unit dwellings:

- \$1,000 per port installed in individually assigned parking spaces
- \$2,000 per port installed in unassigned parking spaces
- A bonus of \$500 per port in unassigned parking spaces located in a DAC



### **Level 2 Destination Charging Stations**

#### **How it Works**

Ideal for workplaces and parking lots where users park for several hours. A high voltage (208–204V) is supplied as alternating current to the electric vehicle, using a standard connector that works for all cars.

(Tesla drivers use an adapter that comes with their car).



### **Eligible Charging Station Locations**

Charging stations must be installed at one of the following types of locations in New York State:



### **Public Facility**

A public facility is a location with at least twenty parking spaces that is open to the general public. On-street parking locations should have at least twenty on-street parking spaces within a one-block radius of the location of the charging stations. Community oriented locations such as churches and non-profit community centers are public locations.



#### Workplace

A workplace site is a parking facility with at least twenty parking spaces that primarily serves employees who work at or nearby the facility. Workplace sites must have a minimum of twenty employees regularly working at the site. Workplaces sites that have over 100 parking spaces at the site will be considered Large Workplace Sites.



### Multi-Unit Dwelling (MUD)

A MUD site is a parking facility with at least twenty (20) parking spaces that primarily serves a MUD with ten (10) or more connected housing units. More than 50% of vehicles regularly parked at a MUD site must be resident owned. MUD sites that have more than 100 parking spaces shall be considered Large MUD sites.
