Comprehensive – Deep Gas Retrofit LTO

Offered by: National Grid Downstate (KEDNY & KEDLI)

- National Grid Downstate Gas Customers: Increased points value for Pipe Insulation, Energy Management System (EMS), and Steam Traps. These measures will be worth 30 points each for projects applying for this LTO
- Important Dates:
 - o Application Due Dates: Applications must be submitted on or before October 31st, 2024 at 5pm Eastern Standard Time*
 - o **Installation Due Dates**: For projects planned to be fully installed in 2025, the projects must be fully installed by October 15th, 2025
 - All paperwork for project close out includes:
 - Signed Statement of Completion (SOC) for the entire project
 - Final project invoices and/or receipts (see Section 10 of the Program Manual)
 - Photo documentation for engineering review if completing virtual inspection (see Section 5.2 of the Program Manual)
- Notes:
 - o Projects can apply for either Tier 1 or Tier 2 incentives using the increased points of this LTO
 - o Only one existing 40-point measure can be included in the scope when applying for this LTO
 - Projects that have already applied to the AMEEP Comprehensive Pathway may be eligible for this LTO upon review of the Program Administrator, and if approved, will have to sign a revised Offer Letter that outlines the revised scope of work
 - Projects over 150 units require pre-approval from National Grid Downstate (and Con Edison if it is a joint project) before applying for this LTO. Depending on project scope, project cost, and any other implications of the project, National Grid Downstate (and Con Edison if it is a joint project) may offer an adjusted incentive. This will be determined on a case-by-case basis. Customers considering large projects should send an email to the implementation contractor (see page 9 below for contact information) containing the following information:
 - Project Name
 - Project address of utility territory
 - Number of buildings
 - Number of units
 - Affordability proxy or rent roll
 - o This LTO cannot be combined with the existing Comprehensive Small Building Envelope LTO
 - o Joint projects in National Grid Downstate and Con Edison territory are eligible for this LTO
