


The Project is designed to make major contributions to further grow New York State as the U.S. hub for the offshore wind industry.

As indicated in Table 10-1 below, significant benefits are expected to be accrued all periods of the Project's contract delivery term.




10.2 Economic Benefits Plan









































10.3.1 Engagement with third party organizations

As noted in the Stakeholder Engagement Plan and Jobs and Workforce Plan included in this Submission, Attentive Energy is supported by various third-party organizations that would be involved in the successful delivery of Attentive Energy's claims and commitments. The Project is supported by a broad and diverse coalition of stakeholders,

included with this

Submission. The Letters of Intent are from Attentive Energy to key partners stating the intention to provide funding for a suite of community investments and environmental and fisheries projects, pending selection of the program that includes those partnerships.

The partners and projects are outlined here and elsewhere in this Submission:

- Community Investment Partners Described in Appendix A of this document and Section 8.3. Further discussion is provided in Sections 11; and
- Environmental and Fisheries Partners Described in Appendix B of this document as well as Section 8.1 and Section 8.2.

10.3.1.1 Methodology for Identifying Beneficiaries and Partners

Attentive Energy has performed due diligence to ensure that its investments lead to sustainable, highimpact benefits to communities. Attentive Energy has prioritized several elements, drawing from extensive stakeholder engagement over the past several years

- Partner readiness: Ensuring partners have the institutional infrastructure to deploy funds and are prepared to effectively manage programs and reporting;
- Right-sizing investments: Budgeting initiative investments based on the stated needs of these partners and maximizing the utility and impact of dollars spent and benefits created;
- Last piece of the puzzle: Seeking initiatives where the Project can provide the last tranche of required funding to kickstart or expand a promising and value-aligned initiative; and
- Building upon a solid foundation: Avoiding duplication of efforts or initiatives proposed by others, or initiatives that are already contemplated and addressed by state/federal grant programs.

As a result of these efforts, the Project offers a portfolio of economic benefits that are targeted, advanced, and tailored to New York communities. These benefits are designed to fill existing gaps while prioritizing investments and partnerships that will be most impactful, with many beneficiary organizations having worked with one or more of the Sponsors in the past. Ultimately, Attentive Energy proposes to maximize

value to New York by leveraging its deep relationships with trusted partners who will ensure the successful delivery of opportunities to New York State, for this Project and beyond.

10.3.2 Engagement On The Ground And Plan To Foster Economic Development Opportunities

For several years, Attentive Energy has made foundational investments in connection with the Project to launch its partnerships and commitments to New York, and to jumpstart addressing some key gaps that need to be understood and resolved to maximize opportunities for New Yorkers (Table 10-5). These efforts have continued into 2024, and a sampling of them are listed below.

Going forward, Attentive Energy will deploy a comprehensive approach to identifying opportunities to build-up the capacity of the communities at the heart of this Project. This will include engaging with MWBEs and SDVOBs in a manner specifically designed to overcome entry barriers in order to maximize opportunities to participate in the Project's, and the broader industry, supply chain. This effort will include a collaborative engagement towards the market by Attentive Energy, its suppliers, and their subcontractors.

10.3.3 Jobs and Workforce Plan

Attentive Energy has designed and developed a comprehensive Jobs and Workforce Plan,

to assemble a network of workforce development, K-12, higher education, organized labor, and community partners to recruit, train for soft and technical skills, reduce barriers for, and credential New Yorkers seeking roles in the offshore wind industry. The New York Jobs and Workforce Plan is summarized in Section 11 and included as a separate attachment in this Submission.

Attentive Energy understands that employing a unionized workforce is essential, and that the Project must be a shared win for both the environmental justice and labor movements. 10.3.5 Compliance with New York State Supplier Opportunity Requirement

10.3.5.1 Supplier Opportunity

This Submission represents a suite of initiatives designed to advance and support regional offshore wind market development. Furthermore, in association with New York State economic benefits, purchases, and engagement, Attentive Energy seeks to maximize supply chain participation from suppliers and prospective suppliers throughout New York State. Attentive Energy and its contractors at all tiers will:

Engaging with Suppliers

Attentive Energy will be responsive to suppliers and prospective suppliers throughout New York State who express an interest in supporting the Project. To best grow sourcing efforts over time, Attentive Energy procurement personnel will develop and maintain a register of suppliers, which will be referenced for any goods and services requests for proposals. Attentive Energy's register will include expressions of interest from the company's website, participants at the company's supplier events, and others who express general interest.

Attentive Energy's Procurement team will engage directly with New York-certified MWBE and SDVOB suppliers and prospective suppliers with a strategy designed to help the supply market adapt to the needs of the offshore wind industry. First, Procurement personnel will devote time to provide meaningful feedback to all MWBE and SDVOB bidders to share any perceived opportunities for improvement, and

generally allow a fuller exchange of ideas than is customary in an environment with an already mature supply chain.

Attentive Energy's procurement team will also work with Attentive Energy's external affairs team and those community investment partners focused on improving the supply chain to respond to the perceived needs of MWBE and SDVOB suppliers and prospective suppliers and provide practical information that can support them. Procurement personnel will participate in supplier-oriented events. Sustained, direct engagement should help New York-certified MWBE and SDVOB suppliers and prospective suppliers increase their participation in Attentive Energy's procurements and better capitalize on opportunities throughout the offshore wind industry more broadly.

Documentation and Reporting

Attentive Energy and its contractors will document all commercially reasonable efforts to maximize opportunities for MWBEs and SDVOBs, including substantiation of efforts to publicize potential supplier opportunities for MWBE and SDVOB suppliers within New York State.

Reporting and verification efforts for MWBE and SDVOB participation will be consistent with Attentive Energy's reporting and verification processes for all local economic- benefit claims.



10.3.6.3 Verification Documentation

Attentive Energy has reviewed the list of substantiating documentation outlined in ORECRFP24-1 which provides the types of acceptable documentation Attentive Energy may expect to submit for verification of New York State economic benefits. Attentive Energy will not include in its reporting indirect or induced benefits or those created by any "multiplier effect" or other attribution method under which the creation of peripheral spending and jobs might be credited to direct capital infused into the economy.

As noted in ORECRFP24-1, Attentive Energy recognizes the provided list is not intended to be exhaustive or final. Attentive Energy and/or its affiliates may use other forms of documentation for a category of expense, subject to NYSERDA's approval. Other forms of documentation may include, but are not necessarily limited to, accounting reports, vendor statements, certificates of attestation and invoices. The principles set forth above for General Contractors may be applied to Attentive Energy's other suppliers where it is deemed appropriate by the IM and/or NYSERDA.


